Successful Recovery Efforts Prompt Service Proposal to Delist Gray Wolf and Focus ESA Protection on Mexican Wolf

The U.S. Fish and Wildlife Service has proposed to remove the gray wolf (*Canis lupus*) from the list of threatened and endangered species under the Endangered Species Act (ESA). The proposal comes not long after the recovery and delisting of the gray wolf in the western Great Lakes states and Northern Rockies as a result of three decades of successful management actions undertaken by federal, state and local partners. However, the Service is also proposing to maintain protection and expand recovery efforts for the Mexican wolf (*Canis lupus baileyi*) in the Southwest, where it remains endangered. The proposal includes the Service's comprehensive review which determined that the current listing for gray wolf, developed 35 years ago, erroneously included large geographical areas outside the species' historical range. In addition, the review found that the current gray wolf listing does not reasonably represent the range of the only remaining population of wolves in the lower 48 states and Mexico that requires the protections of the ESA – the Mexican wolf population in the Southwest.

The proposed rule is based on the best science available and incorporates new information about the gray wolf's current and historical distribution in the contiguous United States and Mexico. It focuses the protection on the Mexican wolf, the only remaining entity that warrants protection under the Act, by designating the Mexican wolf as an endangered subspecies.

**As you will see written time and time again are the words 'Delisted due to Recovery.' Instead of celebrating the recovery of a species like any normal person might do they delist them. The delisting of a species in a trigger-happy culture like the US. is a death sentence, you need only some kind of licence or even an excuse, and anyone can go out there and gun down whatever they like.**

Having read your idea on how we could create more heathland, it's an idea that might well work, but with just three species? It would surely require far more diversity than that. But I can see however it would certainly be worthwhile as an experiment and should as you say attract species like the stone curlew to hopefully breed. Good luck with it and I hope someone takes it up.

**Hi, and thanks for getting in touch. These three species, as the basic building blocks, would go a long way to getting this whole habitat started. Birds and flying insects would of course move in overnight and they hopefully would bring in seeds of all kinds of other plants. I agree it would make a great experiment which is why I put the idea forward in the first place and the boars could always be tendered out to help manage the heaths in the surrounding areas. At the moment these habitats are often overridden with Bracken and Fireweed but by allowing Wild Boars to eat up the rhizomes things could be much improved. They are of course one of our missing native species and should've been brought back decades ago.**

**Heaths by the way come in many forms, wooded heaths where Nightjars occur right through to the more open habitat of bare earth and sparse vegetation, which is the type where Stone Curlews are found. This latter is what I'd expect to materialise with these systems, at least in the early stages, but anything could eventually develop later on. Anyway, thank you once again for your thoughts.**

Thank you for your call regarding the house martin nests. I have investigated the incident in my capacity as a wildlife crime officer.

The owner of the property has been interviewed in relation to the allegation of destruction of the nests. The person has been issued with words of advice. There is insufficient evidence to bring about a successful prosecution with regards to the matter. Should you be aware of any further incident then please feel free to contact me direct. As you can understand we must have sufficient, clear evidence to bring about a prosecution, photographs, cctv etc. I deal with many such incidents and also attempt to educate house owners with regards to birds and the law at every opportunity.
