Instead, Paul's legislation would allow states and localities to decide which animals and wildlife habitat are worth protecting... and which are not.

Stop Rand Paul from sabotaging efforts to save animals like wolves, polar bears, and whales from extinction. Urge your US Senators to oppose S. 855.

We told you this could be the most anti-wildlife Congress in recent memory.

But it's even worse than we feared.

The House Interior Appropriations Subcommittee has released an appropriations bill that is bursting with anti-wildlife provisions affecting wolves and other imperiled wildlife.

If these shocking provisions become law, it would be a death sentence for countless wolves and could set our nation's wildlife conservation efforts back by decades.

URGENT: Tell your Representative to reject anti-wolf and other anti-wildlife measures.

Just consider some of the damage these provisions would do:

A death warrant for wolves. One proposed measure would force gray wolves in Wyoming and the Great Lakes off the Endangered Species List. Once again, these majestic animals' fates would lie in the hands of states intent on dramatically driving down wolf populations. That's a veritable death sentence for hundreds, if not thousands of wolves. In the last year alone, more than 700 wolves were killed in the states covered by this provision.

A blind eye to elephant poaching and ivory smuggling. At a time when the massacre of elephants for their ivory has reached epidemic proportions, the House bill would block efforts by the Fish and Wildlife Service to impose tougher restrictions on the importation and domestic sale of ivory – efforts that are necessary to prevent illegally smuggled ivory from being laundered into commercial trade. Today, an elephant falls to a poacher's bullet every 15 minutes in Africa. This NRA-supported measure is a giant step in the wrong direction. All this proposal does is benefit elephant poachers and ivory smugglers at the cost of elephant lives.

A savage attack on the ESA. Yet another provision would prohibit a potential listing of the greater sage-grouse – an imperiled bird that has waited more than a decade for a listing decision.

In addition to these despicable appropriations provisions, there have already been more than 50 amendments or bills introduced by Congress aimed at gutting the Endangered Species Act.

These legislative proposals are the product of special interest lobbying and political extremism. They are wildly out of touch with what most Americans want and believe.

This is the moment we need to stand together and demand an end to the insanity on Capitol Hill!





#### Dear Mr Pagan

Thank you for your email 11 May to the Department of Energy and Climate Change (DECC), about concerns on wind farms and wave energy. I have been asked to reply.

I appreciate you taking the time to highlight your concerns over wildlife. Any form of developments going through the planning process can have an impact on wildlife, and that is why we are clear that any projects must be appropriately sited where any impacts are, or can be made acceptable.

Nevertheless, you will be pleased to know that the Conservative manifesto set out a commitment to end new public subsidy for onshore wind farms, as well as make changes to planning to give local people the final say on windfarm applications. Now that the new government has been appointed, DECC officials are working through how these proposals will be implemented. We will publish further details on policy proposals and consult in due course. All relevant information will be made available on the gov.uk website.

In relation to wave energy, wave and tidal energy has the potential to make significant contribution to meeting the UK's long term low carbon/renewable target in the period beyond 2020. A significant portion of the tidal stream resource is in Scotland. The Government has a long history of supporting the development and deployment of wave and tidal stream technologies in the UK. To date we have provided sustained and targeted support enabling the wave and tidal stream sectors to move from initial concept onto prototypes and now the first arrays.

Over 7MW of wave and tidal stream devices have been deployed for testing in the UK. This includes the world's first commercial scale tidal stream turbine (MCT SeaGen 1.2MW). The world's first tidal stream array (MeyGen, 6MW) due to deploy in 2016. We have the world's most advanced marine energy testing facilities with the European Marine Energy Centre (EMEC) in the Orkney, Wave Hub in Cornwall, the Offshore Renewables Catapult and world class UK academic centres. The industry also receives significant support from the Devolved Administrations in Scotland, Wales and Northern Ireland.

The Government remains open to considering any well-developed proposals for harnessing the tidal range energy in the estuaries around our coastlines, including barrage and other alternatives. Any tidal range scheme would need to demonstrate strong evidence of value for money, economic benefits, energy saving and environmental impact mitigation before the Government could take a view on its potential.

I hope that this is helpful.

Fantastic news – Onshore wind subsidies to be cut – so wind farms in areas with low wind will not be worth building.

The election of a Conservative Government in the 2015 General Election will become a major turning point in policies towards on-shore wind farms. There is a lot going on and the new Minister with responsibility for Energy, Andrea Leadsom MP is already hard at work on delivering the Conservative manifesto pledge to stop new subsidies for onshore wind farms.

The high subsidies have driven a feeding frenzy by wind farm developers and this is a UK wide issue. It is also important in Selby District, where we have more than our fair share of wind farms and single turbines proposals. Single turbines being proposed today can be nearly 100 metres high, which is larger than turbines used on wind farms a few years ago.

This briefing summarises the progress being made and current challenges. For each of the topics covered there are then links for further information. The topics covered are as follows

1. Wind farm subsidies. Progress towards the Conservative manifesto pledge – and why people faced with turbines are so determined to stop them

I hope that you confirmed your support for cutting wind farm subsidies when Nigel Adams asked for support of his campaign – if not you can still do so via our website. Cutting wind subsidies was an election pledge from the Conservatives and almost as soon as she took up her appointment as Energy Secretary, Andrea Leadsom met with Nigel Adams to seek ideas. Needless to say the wind industry which gets nearly £2BN per year in subsidy is up in arms and fighting to retain as much of the subsidy as they can.

While the focus is on subsidy the real objective is to stop imposing wind farms on communities that do not want 400 foot high structures located close to where they live.

The main objection to wind farms is the size of the turbines and proximity to homes – see our web page for links to before and after pictures - there is a growing body of evidence that wind farms and especially the noise they produce is harmful to health. 2. Lumby turbine appeal – site visits by the Inspector

The turbine proposed at Lumby (87 metres high) and was refused planning permission by Selby District Council. The decision was appealed and the appeal is now ongoing. The Inspector is Zoe Hill – up to May 2014 she had dealt with 18 wind farm appeals and had refused 12 of them. A site visit is to take place on 10 June and the decision is not expected to be made until July. It is not clear if the appeal, which was recovered by Eric Pickles after a request from Nigel Adams will still be recovered or whether the decision will be taken by the Inspector. As soon as we have more information we will make it available.

3. Bishopwood – Surprise news that another company plans to submit an application.

The appeal by Prowind against the refusal of the 7 turbines at Bishopwood will be heard at an Inquiry starting 24 November 2015.

In addition to this we have learnt that a new company called Horizon Power is preparing another planning application for 7 turbines with 6 on the same site and another further to the West. The Managing Director of the company is Keith Brooks who until recently was the manager of Prowind UK operations. Given the cost and time it will take to produce the necessary Environmental statement and the proposed changes in the level of subsidy we are surprised by this move which appears to us to have very little chance of ever making any money. 4. Outrage at proposal for two turbines on the hill next to Almscliffe Crag – the wind farm developer placing no value on a unique landscape.

People who live in the country generally put a high value on their surroundings. Wind developers place no value on the countryside. This is perfectly illustrated by a proposal to put two large turbines on top of the hill next to Almscliffe crag. There has been a spate of single turbine applications in Lower Wharfedale and the villages there have always delivered feisty opposition. This latest proposal has resulted in hundreds of objections including the Harewood estate. If you don't fight them, you get them. More about the Almscliffe turbines and how you can object.

5. Update on other wind farms and turbines in Selby District

Hook Moor – 5 x 125 metres – construction started – falls just inside the Leeds boundary. Green belt. The turbines should be up by late summer, access roads and excavation for the 1000 ton concrete bases now underway. Visible from the A1M / M1 junction.

Cleek Hall  $-5 \ge 125$  metres - this was approved some time ago and we do not know when construction will begin. It will be a dominant landmark near to Selby bypass and the existing 87 metres turbine, which will be dwarfed when these much larger turbines are put up.

Woodlane – 14 x 125 metre turbines – still an active planning application – the fight continues even after 6years.

Darrington Quarry – 8 x 125 metre turbines – the application will be decided by North Yorkshire County Council when the applicant submits all the required information, some of which has been outstanding for over 5 years.

Single turbines -

•New application for a single turbine of 42 metres at Whitley

•Riccall , pending appeal decision, expected soon.

•Oaktree Farm - 87 metres – application to be decided by Selby District - subsidy of about £200K per year.

•Stapleton – 87 metres – application to be determined by Selby District – another turbine in a prominent position in Green Belt - subsidy of about £200K per year.
