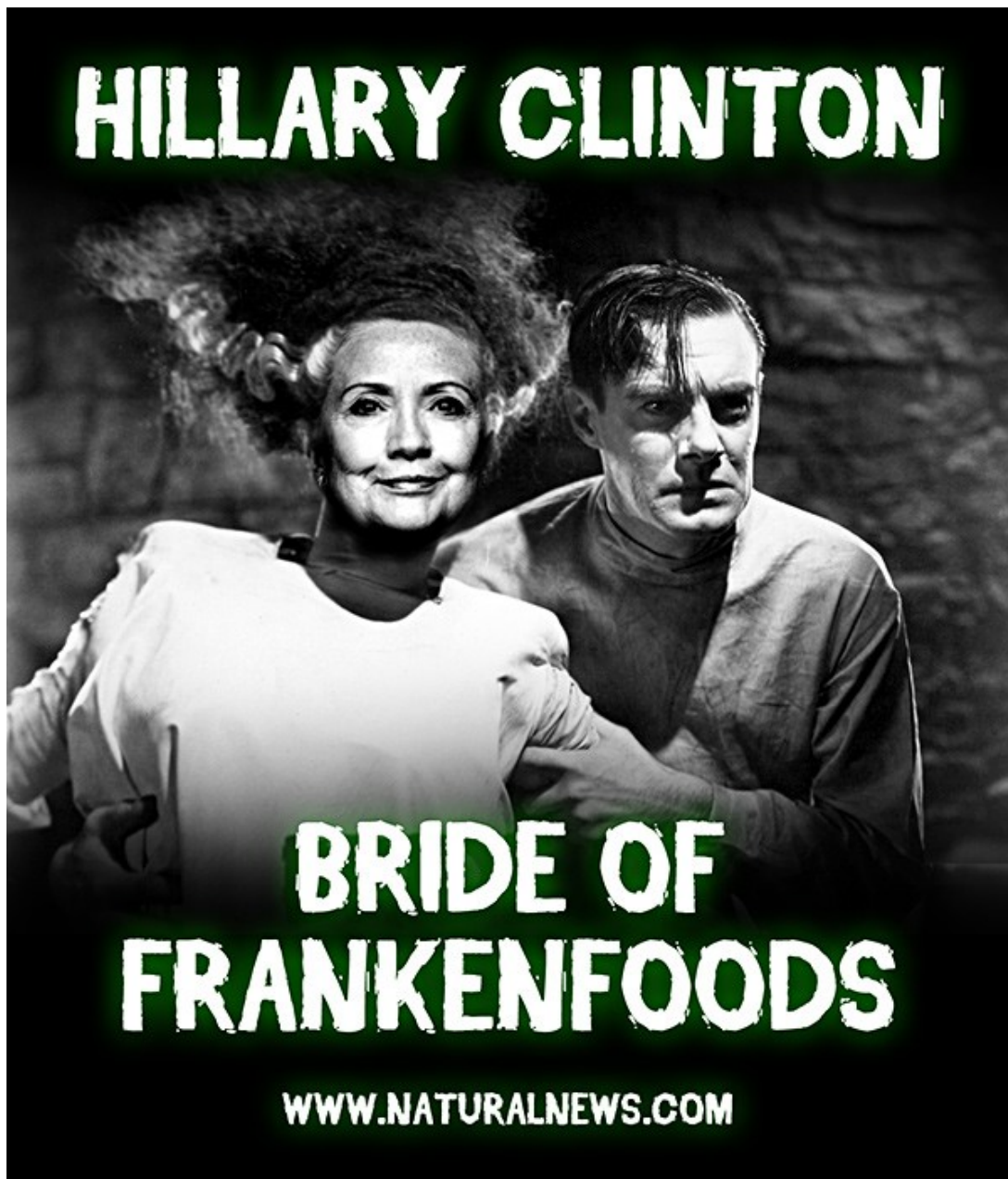


Here are some more articles and replies. In order to simplify, our comments are written in Times New Roman and in block while the letters and articles are in Arial.

Hi George

Thank you for your patience whilst I have been waiting to hear from our Technical Team about the Hero Complete Dried Dog Food.

I've been advised that **we do not add** any artificial preservatives or antioxidants **to the formula.** However, they are present in some of our ingredients, mainly the meat, fats and vitamins and minerals. They are added to these ingredients, as without them they are unstable, and can start to oxidize quickly producing rancid flavours and reduced nutrition.

This is particularly the case with the vitamins which can lose efficacy if they are not treated appropriately resulting in a reduction in the amount the animal receives in their diet. The amount of antioxidants and preservatives present in the food is very small in parts per million.

Once again, thanks for contacting me and I hope I have helped. If I can be of further help, please let me know.

In this letter from Asda they state that they 'do not add any artificial preservatives or antioxidants to their formula,' but in the same paragraph say 'they are added to the ingredients' all of which ends up in the finished product. By not adding them to the formula itself, and reading between the lines so to speak, they can then get away with not declaring these additives on the packet.

This being the case it is absolutely outrageous. The public has every right to know what's contained in their pet food, within all stages of the process, in order that they may make an informed choice when purchasing. And not, as in this case, to read nothing about them on the list and only after contacting the company by email to find out that it has artificial additives in it all the time.

Given all supermarkets operate to the same sloppy standards with their dried 'complete' pet food we've decided to bring them all in on this. Natural alternatives exist, like E300 L-Ascorbic acid or tocopherol etc. Please write to the following contacts and say we want to know exactly what's in our pet food.

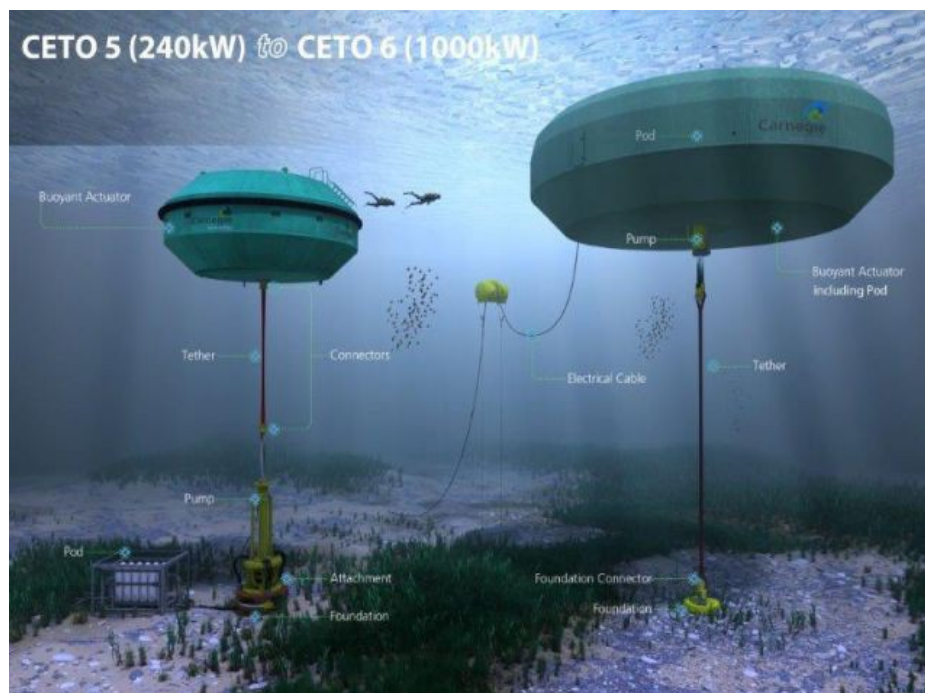
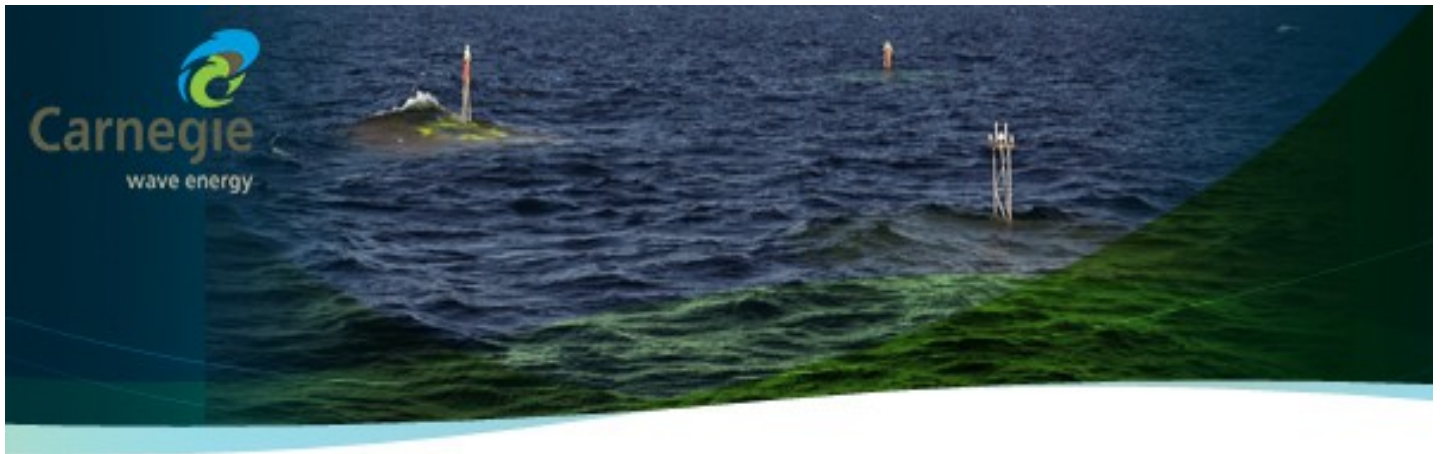

Dear Mr Piller,

Thank you for your email dated 25 June to Amber Rudd, about onshore wind subsidies. I have been asked to reply.

The Government was elected with a commitment to end new subsidies for onshore wind and to change the law so that local people have the final say on onshore windfarm applications. Onshore wind has made a valuable contribution to the UK energy mix in recent years but there is now enough capacity in the pipeline for the UK to meet its 2020 renewable commitments. We have therefore announced that we will be introducing primary legislation to close the RO to new onshore wind from 31 March 2016 – a year earlier than planned.

I hope that this is helpful.

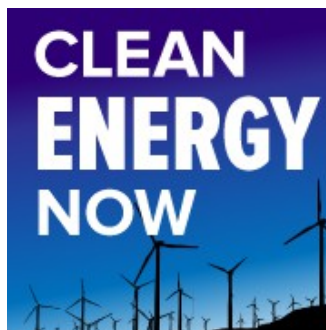
